The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *ten* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Punta Arenas and any ports and places on the Western and Eastern Coasts of Central, North and South America and West Indies, North and South Atlantic and Pacific Oceans, Cape and Australian Colonies, Indian and China Seas, the Continent of Europe including the Mediterranean Sea to and fro for any period not exceeding two years and back to the final port of discharge in the United Kingdom.*

Provisions issued as per the 'America' voyage, 1863-64.

When 2oz of butter is issued daily the allowance of meat will be ½ lb less per man. No spirits allowed. Equivalent at the Master's option.

Crew to attend divine service when required. Swearing or other bad language strictly forbidden.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
