

AGREEMENT AND ACCOUNT OF CREW
FOREIGN GOING SHIP

(IRAZU – 3 SEPTEMBER 1870 – 22 JULY 1871)

The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *six* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Talcahuano, Iolay, Callao, Punta Arenas and any other ports and places on the West Coast of North and South America and islands adjacent, and back to the port of final discharge of cargo in the United Kingdom or Continent of Europe between the Elbe and Brest. Voyage not to exceed two years.*

Provisions issued as per the ‘America’ voyage, 1863-64.
Equivalent substitutes at the Master’s option. No spirits allowed.

In the event of any member of the crew not being on board at the time stated in the agreement the Master shall have liberty to ship another in his place.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
