The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *thirteen* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Monte Video, Punta Arenas and any ports and places in the Western and Eastern coasts of South Central and North America North and South Pacific and Atlantic Oceans Cape and Australian Colonies West Indies India and China Seas and Straits and the Mediterranean to and fro for any period not exceeding two years and back to the port of final discharge in the United Kingdom or Continent of Europe between the Elbe and Brest.*

Provisions issued as per the 'America' voyage, 1863-64.

No spirits allowed. Equivalent substitutes at the Master's option.

No swearing or prophane language allowed. The vessel shall be considered fully manned with sixteen hands all told.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
